[Level 3 - Public Health Measures Currently in Place & Christmas 2020 Measures](#) from 18.12.20

Ireland is currently at [Level 3](#).

From **Monday 1st December 2020**, Ireland has moved to **Level 3** of the Government's [Resilience and Recovery 2020-2021: Plan for Living with COVID-19](#).

For **Level 3 Measures** in operation from 1st December 2020 Click [HERE](#).

At Level 3, the public health measures include that citizens should work from home unless absolutely necessary to attend in person. Face coverings are recommended in crowded workplaces.

Citizens should stay in their own county, apart from work, education, medical and other essential purposes, if appropriate.

There are restrictions on social and family gatherings, including that citizens should **not mix in their homes or gardens** with any other households outside of those within their **own support bubble**. Other outdoor settings **outside the home or garden** permit **up to 6 people from a maximum of 2 households** meeting, while maintaining strict physical distancing. Face coverings are recommended in busy or crowded areas.

Christmas Measures 2020

Subject to ongoing review of the trajectory of the virus, from 18th December 2020 until 6th January 2021 inclusive, there will be a slight easing of restrictions in relation to **social and family gatherings**, where citizens can mix in their homes or gardens with **a maximum of 2 other households**. Other outdoor settings **outside the home or garden** permit a **maximum of 3 households meeting**, while still maintaining strict physical distancing. Face coverings are recommended in busy or crowded areas.

From **7th January 2021**, the measures put in place prior to 18th December 2020 (i.e. those from 1st December 2020) will apply again.

Veterinary Profession - Maintaining Vigilance

While Level 3 means that veterinary practices and other essential veterinary workplaces can remain open, and veterinary practitioners can undertake their duties to animals and to their client owners, keeping up protective behaviours is as important as ever to prevent the spread of infection.

While much would be commonly applied by veterinary professionals, such as good hygiene and biosecurity, HSE guidelines must still be followed to minimise the risks in the current circumstances; including knowing the symptoms of COVID-19 and isolating and contacting your GP if you have symptoms, social distancing / 2m away from colleagues where possible, wear a face covering (for CDC advice on face coverings Click [HERE](#)), practice good respiratory-hygiene and hand-hygiene, and maintain a log of who you meet each day.

COVID-19 VACCINATIONS

The Government has just published its COVID-19 Vaccination Strategy and Implementation Plan, which outlines Ireland's high-level plan for safe, effective and efficient vaccination of the population, while safeguarding continued provision of health and social care services. The National COVID-19 Vaccination Strategy was prepared by the High-Level Task Force on COVID-19 Vaccination.

Those over the age of 65 living in long-term care facilities and frontline healthcare workers in direct patient contact, will be the first to receive the vaccine, followed by those aged over 70, with those in the 85+ age group being vaccinated first, followed by 80-84, 75-79 and 70-74 age groups in that order. Other healthcare workers will be next, followed by those aged 65-69, with priority for those in this age group with pre-existing medical conditions. Key workers will receive the vaccine next, followed by those in the 18 to 64 age group who are deemed high risk, are resident in long-term resident facilities or live/work in crowded conditions.

Group
Adults aged ≥65 years who are residents of long-term care facilities. Consider offering vaccination to all residents and staff on site.
Frontline healthcare workers (HCWs)* in direct patient contact roles (including vaccinators) or who risk exposure to bodily fluids or aerosols.
Aged 70 and older in the following order: 85 and older 80-84 75-79 70-74.
Other HCWs not in direct patient contact.
Aged 65-69. Prioritise those with medical conditions** which put them at high risk of severe disease.
Key workers (to be further refined) including those providing services essential to the vaccination programme e.g. logistical support.
Aged 18-64 years with medical conditions** which put them at high risk of severe disease.
Residents of long-term care facilities aged 18-64.
Aged 18-64 years living working in crowded accommodation where self-isolation and social distancing is difficult to maintain.
Key workers in essential jobs who cannot avoid a high risk of exposure to COVID-19. They include workers in the food supply system, public and commercial transport and other vital services.
Those who are essential to education and who face disease exposure - primary and second level school staff, special needs assistants, childcare workers, maintenance workers, school bus drivers etc.
Aged 55-64 years.
Those in occupations important to the functioning of society, e.g., third level institutions, entertainment and goods-producing industries who work in settings where protective measures can be followed without much difficulty.
Aged 18-54 years who did not have access to the vaccine in prior phases.
Children, adolescents up to 18 years and pregnant women (to be refined).

*Includes health care workers who work in and out of all healthcare settings

**Chronic heart disease, including hypertension with cardiac involvement; chronic respiratory disease, including asthma requiring continuous or repeated use of systemic steroids or with previous exacerbations requiring hospital admission; Type 1 and 2 diabetes; chronic neurological disease; chronic kidney disease; body mass index >40; immunosuppression due to disease or treatment; chronic liver disease.
